s part of efforts to continue to sensitize the Nigerian public about the value of research and the role of research ethics in protecting participants in research projects, the Federal Ministry of Health of Nigeria (FMOH), National Health Research Ethics Committee of Nigeria (NHREC), United States' Center for Diseases Control and Prevention (CDC) and the West African Bioethics Training Program (WAB) conducted a training program on Modern Research Ethics and Collaborative research for journalists in Nigeria. This is part of the joint efforts of the stakeholders to ensure that Nigerians understand the value of research and be reassured that their rights and welfare are protected when they volunteer to participate in research projects. This is the second of such training organized for journalists in Nigeria since a previous one in April 2013. This training introduced the journalists to research ethics, highlighting the role of the media in informing the public accurately, ethically and fairly about research and research ethics. Participants were encouraged to suggest ways that the media in Nigeria could better engage with and contribute to protection of human research participants.

A total of 25 journalists from various media outfits including Nigerian News Agency (NAN), Nigeria Television Authority (NTA), Channels TV, ITV, Thisday Newspaper, Daily Trust Newspaper, Daily Independent Newspaper, Compass Newspaper, National Trail Newspaper, National Mirror Newspaper, Kapital FM Radio Station, and Vision FM Radio Station. The Deputy Director for Press Affairs, as well as nine (9) other press officers from the Federal Ministry of Health attended the training.





Highlights of the training

During the course of the training, the following presentations were made and discussed: History of Bioethics and Research Misconduct: the role of the media: This was presented by Prof. A. Malomo. The presentation highlighted some instances of research misconduct in history and the role that the media played. These instances included the Nuremberg Experiments, Tuskegee Syphilis Study and the Trovan Trial, in Kano Nigeria among others. While the media was shown to have played active roles in bringing some of the instances of unethical conduct of research to the fore and contributing to the eventual action(s) that were taken by authorities to address the issues; the media played passive roles in other instances. Overall, it was recommended that the role of the media should be towards promoting societal good through objective reporting of issues as they are.

Role of media and society in fostering good research involving human beings:

•This presentation discussed the role that the media can play in promoting ethical research. The presentation recommended that the role of media in fostering good research should be based on the following principles

- Information for genuine enlightenment.
- Education for holistic personal development and enhancement.
- Entertainment for genuine refreshing, inspiration and re-invigoration.
- Ethical social engineering.

The argument was made that applying these principles in research will help the ethical media reporter/editor to synthesize information that they can report either for awareness creation, generating debate, or facilitating action to be taken by responsible authorities.

Legal, Philosophical and Moral Foundations of Bioethics:

Dr. Adebayo Adejumo gave a historical account of legal decisions/provision related to research ethics, including the trials of the Nazi doctors at Nuremberg and the Tuskegee trials among others. It was argued that the latter was the main driver behind subsequent developments in protection of human research subjects in the United States including the Code of Federal Regulations 45, sub part 46.



Highlights of the training contd.

The various philosophical theories and principles that are used as basis for ethical reasoning were also highlighted. The need to balance the application of these theories and principles, with societal morals was also highlighted.

Phases of clinical trials and what makes research ethical:

This was presented by Mr. Lawrence Fagbemiro of the Department of Food and Drugs Services, Federal Ministry of Health and graduate of the West African Bioethics Training Program. The presentation highlighted the various phases of clinical trials and the ethical issues that are inherent in each of the phases. In ensuring an ethical trial, the eight benchmarks elucidated by Emmanuel et al in their article "what makes clinical research in developing countries ethical? The benchmarks of ethics research" were extensively discussed.

Informed Consent: Dr. Adebayo Adejumo gave a presentation that highlighted the importance of informed consent as a sine qua non for ethical research. Participants were made to understand that informed consent was a continuous process. Re-consenting participants may become necessary if there is new information that has affected the risk-benefit balance of the study. Researchers are to ensure that participants have full understanding and comprehension of the study, its risks and potential benefits and agree to participants of their free will without any undue pressure.

NHREC, HRECs and their roles in Health research in Nigeria:

This was presented by Mr. Aminu Yakubu, the NHREC administrative officer and a graduate of both the Johns Hopkins and WAB training programs. His presentation highlighted the evolution of health research ethics committee globally and in Nigeria citing experiences of unethical research practices as the major drivers. In Nigeria, the National Health Research Ethics Committee provides the guidelines and ensures adherence to these guidelines for ethical research among ethics committees and researchers. Through its registration mandate, NHREC has been able to categorise ethics committees in Nigeria according to the types of studies they can approve. It is important for researcher to know which ethics committee is right to review their proposed studies. Modern Research Ethics Training

for Members of the Health Research Ethics Committee of the College of Medical Sciences, University of Benin, Benin City Nigeria

A two-day workshop was organized by the West African Bioethics Training Program, Ibadan (WAB) in collaboration with the College of Medical Sciences, University of Benin, Benin City. The drive for the implementation of this workshop and the constitution of the ethics committee at this institution was led by Professor Olubunmi Ogunrin, a neuroscientist and West African Bioethics Training Program graduate who had also led the development of the Nigerian training module on the Collaborative Institutional Training Initiative (CITI) online ethics training platform. He was assisted by Dr. Omokhoa Adeleye, a member of faculty of the College of Medical Sciences, University of Benin, Benin City and a West African Bioethics Training Program graduate.

The training curriculum was accredited by the Nigerian National Health Research Ethics Committee (NHREC/TR/20/08/2013). The aim of the training was to strengthening the skills of members of the committee on how to review research protocols in order to achieve ethical clearance. The training came up between the 9th and 10th of September, 2013 at the University of Benin Teaching Hospital, Benin City. In attendance were 21 participants and 2 facilitators..

A total of nine training sessions were taken, these include

- Meaning and history of research ethics
- Principles of research ethics
- Guidelines for HREC approval of research
- Requirements for research conduct
- National Code of Health Research Ethics
- HREC registration, membership, functions and operations
- Categories of ethical review of research proposals
- International collaborative research
- Scientific misconduct

Various participatory mechanisms were used to facilitate learning during the training. These include: brainstorming, question and answer sessions, cases studies, plenary discussions.

The workshop evaluation showed that participants had indeed acquired new knowledge and skills. The mean pre-test score was 47%, scores ranged from 33% to 80% with three persons scoring less than 50%. The mean post test score was 78%. They all could identify new skills they had acquired and the new things they plan to do with the skills acquired.
