1.0 Masters' degree training in Bioethics

1.1 M.Sc. Bioethics at the University of Ibadan, Ibadan, Nigeria

We continue to support the implementation of the highly successful postgraduate degree training in Bioethics at the University of Ibadan, Nigeria. 10 students were admitted into the MSc Bioethics program during the 2020/2021 session. These students have completed their coursework and are now working on their research projects.

The process for admission of students into the MSc Bioethics program for the 2021/2022 academic session has commenced. 1.2 M.Sc. Bioethics at the University of Nigeria, Nsukka, Nigeria

The MSc. Bioethics program at the University of Nigeria which is supported by the Center for Bioethics and Research has been highly successful. The pioneer students that were admitted for the program during the 2020/2021 academic session have successfully completed their course work and are currently working on their research project. A new set of 6 candidates have been shortlisted for admission into the program for the 2021/2022 academic session.

1.3 MPH with Bioethics concentration at University of Nigeria, Nsukka, Nigeria

CBR works with the Department of Community Medicine, University of Nigeria, Nsukka (UNN) to implement a Masters in Public Health (MPH) with Bioethics concentration program. The objective of the program is the rapid training and development of bioethics researchers in Nigeria. Interested MPH students who have completed their course work are eligible to apply for the program. After interviews, the top 5 candidates were selected. The successful candidates conduct their MPH research projects on bioethics topics and complete CBR's blended diploma in research ethics. The first cohort of trainees in this program recently completed their research and was examined by faculty members from the MPH and Bioethics degree programs at UNN.

The candidates and their research topics are: Ms. Chisom Ebube Chris-Onu, 'Knowledge and Perception of Health Research Ethics among Health care Professionals in Enugu'; Ms. Victoria Ukpaka, 'Perceptions of research misconduct among medical researchers in southeast Nigeria'; Ms. Chisom Ngwu, 'Communication Strategies as vital instruments for enhancement of the

informed consent process in a culture-bound society, Nigeria'; Mr. James Ver Ityough, 'Evaluation of the activities and operations of research ethics committees in research and training institutions in southeast Nigeria'; and Mr. Chukwukelu Victor Nnabu, 'Public Perceptions and Impediments to the return of Health Research Results and Incidental findings to Research Participants'. The second cohort of students for this program is currently being evaluated.

1.4 Online Collaborative Institutional Training Initiative (CITI) in collaboration with BRANY, New York

As part of our partnership with the Biomedical Research Alliance of New York (BRANY)'s CITI program, we provided 8,520 online CITI trainings in Informed Consent, Responsible Conduct of Research, and a specialized module on the Nigerian National Code for Health Research Ethics from the 31st of March 2021 to 15th December 2021.

1.6 My MSc. Bioethics (University of Ibadan) experience by Mordecai Owajioniro, (2020/2021 student)

Taking a step further after Online Blended Diploma in Bioethics at CBR, Ibadan, Oyo State, Nigeria:

In the words of Henry Ford, "Anyone who stops learning is old, whether at twenty or eighty. Anyone who keeps learning stays young". Brian Tracy, my favorite author has this to say, "Continuous learning is the minimum requirement for success in any field."

My awareness of the existence of the field of bioethics was the best miracle that happened to me in 2018 when my quest for professional diversification got to its pinnacle. This quest for professional development had led me to take a short and modular online course in the field of clinical trials offered by Global Health Network as well as Protecting Human Research Participants course by NIH Office of Extramural Research that further deepened my overall interest in research. Little did I know I was gradually diving into the world of bioethics by taking those courses among which are informed consent, introduction to clinical research, good clinical

practice, protecting human research participants, etc. This journey led me to discover and apply for CBR's Blended Diploma in Bioethics in 2018 but I was shortlisted for admission in 2019. The admission came with unquenchable joy and excitement because at the time my interest in bioethics had just begun to swell unimpeded. The experience of the diploma training is unforgettable, especially with my exposure to stakeholders in the field and the 2019 set of students who are just too wonderful to associate with.

During the last session of the second weekend retreat for my set, I became aware of the opportunity for a fully sponsored MSc. program in Bioethics at the University of Ibadan, Nigeria and I said to myself, I cannot afford to miss this rare opportunity. Without further delay, my colleagues and I inquired as to when the opportunity would be available, and we were informed that the Postgraduate College of the University of Ibadan had just closed the sale of forms and was getting ready to conduct the examination for English proficiency the following week. I was beginning to be sad in my spirit because I could not imagine myself missing the admission for that session, but again there was another miracle. Prof. Jegede asked how many of us were interested in admission for the MSc. Bioethics program and about six (6) of us indicated interest. When he saw the number of us (almost 50% of the participants) interested, he instantly placed a phone call to the Provost of the Postgraduate College to plead for an extension on the sale of application forms which will allow us to purchase the form. A month later, Prof. Jegede called to say the Provost has granted his request for extension. To the glory of God, all of us that bought the application forms were admitted after a long delay because of COVID-19 Pandemic which obstructed the academic calendar.

After one year of waiting, we finally resumed lectures online precisely on the 6th of April 2021, because of the instituted measures to mitigate the spread of COVID-19 it is now on record that we are the first set of students (2020/2021 set) to run the program online throughout the first semester and spanning into the second semester. We are also the first set of students to be admitted for the program in the new Department of Bioethics and Medical Humanities. The program was formerly domiciled in the Department of Surgery.

Online lectures had posed a great deal of challenge to me and some of my colleagues, I believe this was caused by lecture times that coincided with other personal engagements, especially office work, but my colleagues in the office, to whom I am grateful were of great help to me.

We completed five courses in the first semester. The first module was (Introduction to philosophy) which started with some elements of familiarity as Prof. Agulanna introduced the course with historical facts that made me feel at home, we progressively got to the peak of the course when the likes of Prof. Abass, Prof. Oduwole, Prof. Okpokolo, and Dr. Victoria charged us with intellectual fireworks alongside assignments, term papers and readings. At a point, I asked myself when will this module end? But again, it was quite intriguing as my perception of life began to change when I learned about the various moral and ethical theories that govern man's

behavior. While I was grappling with finishing the assignments and term papers to beat the deadlines, the next module was up and running.

Foundations of Modern bioethics came with volumes of reading materials, presentations, and group research proposal writings. The course director Prof. Adejumo was at his best as he took us on a voyage into the world of bioethics with seamless effort. It was obvious the depth of commitment from Prof. Adejumo as he often referred to the program as his baby program. His class was always exciting - no dull moments at all.

Principlism propounded by Beauchamp and Childress and Precautionary principles were the high points for me in this module. Even though we had more than enough materials to chew, with the help of Prof.

Adejumo we finished chewing all without knowing how we were able to achieve that. The course has helped me come to terms with decision-making, especially when faced with a dilemma.

Dr. Eyelade welcomed us to the third module on the program as she and other lecturers took us into the world of informed consent and management of ethics committee. She took us on a ride into the historical development of Bioethics with the Nazi experiments, the Tuskegee Syphilis Study, and the Pfizer's Trovan trial which was particularly interesting to me. The video of Miss Evers' Boys trial drove home the needed points.

While we were marinating in the wonderful and unforgettable experiences with Dr. Eyelade and other astute internationally acclaimed lecturers and the content delivered, Prof. Ajuwon' welcomed us to the domain of Research Designs. Different types of research designs ranging from experimental to descriptive and controlled trials were explicitly explained. Teaching and Writing Methods in Bioethics was the last course for the first semester, but it felt like we just started the semesters.

Prof. Omobowale' passionately brought the beauty of literature in medicine to the fore making me love every aspect of it. As a result, I can sit down and write more than five pages of a short story of an event that took place in my office some time ago. Dr. Ayo worked with Prof. Omobowale on this module, he was great at delivering lectures and preparation of lesson notes. His stories were touching, and they helped me have a perfect understanding of the lecture. I wished his part of the lectures should never end. Prof. Odebunmi also worked with Prof. Omobowale, he practically took us through the rigors of writing a research project as well as the process of paper publications in reputable journals as well as the characteristics of predatory journals. After a one-week break, we resumed for the second semester with Prof. Ike Ajayi who unveiled the world of quantitative research methods. It wasn't easy at all, but it came with great learning from Prof. Ajayi, Dr. Dairo' and Dr. Joshua who bombarded us with statistical fireworks.

I could not wait to meet Prof. Jegede, the man God used to work out the miracle of my being an MSc. bioethics scholar. Prof. Jegede guided us into the realm of qualitative research methods, another module on the program. The course sheds light on the right method to be used in our proposed research. The fact that the lectures were interactive made learning easy for me. With all the motivation and positive influence from the crop of lecturers and students, I hope to take a step further in the field of bioethics.

The choice of lecturers on the MSc. Bioethics program attests to the fact that the organizers really mean business as all the lecturers impacted greatly in my life. It will be difficult to forget them because they certainly have become a part of my success story. They are phenomenal and seasoned in their various fields. The administrative staff of the Center for Bioethics and Research (CBR) are a team of professionals that you can always depend on. They are always there to help. Mr. Olusegun Adeyemo was always there to guide us through the admission and clearance process, keeping us updated with necessary information about the course and ensuring we beat deadlines especially when we took the required CITI courses. No lazy or unserious person can do this kind of program. He is a true manager indeed. I call him the doyen of CBR.

Mr. Akinwale Akinjiola is the one who ensures that zoom links are ready before lecture time and is always there with us in class to ensure hitch free lectures. Sometimes, when we had lectures as early as 6am, he never complained that it was outside official time. What a commitment!

Mr. Rasheed Taiwo, the mentorship support guru. He always picks my call to make sure things work out as planned.

Truth be told, the students in the 2020/2021 set are just too intelligent. Each of us has something to bring to the table. I can easily relate with anyone of them. Having 50% of the entire class from the 2019 set of blended diploma program made it easier for me to relate with everyone. My fellow students have been wonderful during lectures, group discussions, presentations, assignments, and term paper writing. Although most of our meetings were held virtually, it felt like we were seeing each other face to face.

2.0 Blended Diploma in Research Ethics

2.1 Current Blended Diploma in Research Ethics Training

A total of 41 applicants were admitted for the diploma program this year, they were divided into 2 batches for training. The first batch of applicants completed their training in November 2021. At the end of their 2 - month training the participants assessment of the program through an online questionnaire that was administered showed that all the respondents rated every aspect of the program as excellent. The second batch of participants will commence their training next year.

The Blended Diploma in Research Ethics is for individuals with interest in research ethics who desire to acquire more competence in research ethics and bioethics but are unable to take advantage of the 18 months fully sponsored M.Sc. Bioethics program at the University of Ibadan and University of Nigeria. The Program is generously funded by the United States' National Institutes of Health Fogarty International Center and the National Human Genome Research Institute.

One of the participants of the diploma program shares his experience in the following write up:

2.2 My experience as a participant of CBR Blended Diploma program

My experience on CBR Blended Diploma can be summarized as a maximal benefit with no risk involved after the benefit-risk ratio assessment. The experience 'started before it even started.' I received interesting online training on some aspects of research ethics through Online Collaborative Institutional Training Initiative (CITI) program – part of the requirements when it is time to apply for the Blended Diploma Program - last year. Immediately the call/advert for the 2021 Blended Diploma was out, I submitted my application for onward review within two weeks from the date of its announcement. I obtained approval (letter of admission) in late July.

Upon being admitted, I knew I was in for an interesting research life in research ethics. I was so eager to take off and 'couldn't wait for September - commencement month - to arrive'. Suffice to say that I see the preparation of CBR towards the program as one of the signs the program is going to be educative. A month before commencing, the Program Coordinator had emailed to notify us of the imminent arrival of the main textbook (Institutional Review Board Management and Function by Robert J. Amdur Elizabeth A. Bankert) to be used to our addresses, which did arrive. Several online materials were sent through email also. As one who is passionate about the protection of human subjects in a research study (a member of my institution's

Health Research Ethics Committee), reading through this textbook and online materials brought pleasure to me. I was enlightened on various concepts even before commencing the program.

The first week (September 13-19) of the program came and my expectations were not disappointed. The contents of the video presentation for the week were concise and the materials dispensed knowledge with accuracy. The weekend chat room session was another aspect I always look forward to, where I do marvel at the way our facilitators answer questions posed to them as one having authority indeed in research ethics. This weekly cycle of e-learning continued for four weeks. However, during all those days of the four weeks, the research question 'Who are these?' kept coming to my mind. I was looking forward to receiving the answer to my question by seeing our facilitators (lecturers) face-to-face in the weekend retreat and the brain behind the well-organized program (Manager and Program Coordinator of CBR).

The commencement day of the first-weekend retreat was so much approached with enthusiasm. I arrived at the venue of the retreat (Davies Hotel, Bodija, Ibadan) and was warmly welcomed by the Program Coordinator and Manager of CBR. They encapsulated me with love and humility. They were so eager to lend a helping hand per time. 'This is definitely an enjoying research life in research ethics', resonated in my heart. I rested for a while in the accommodation prepared for my convenience and later had my prepared lunch.

The first-day lecture started with Prof. Jegede taking the lecture. The boldness with which he lectured confirmed my experience in the online chat room session. Throughout the remaining two days of lecture, the addition of the calmness of Prof. Ogundiran and the fluency of Prof. Adejumo was lovely to behold. These three were indeed erudite professors with expertise and deep knowledge in research ethics. The key moment of the first-weekend retreat was when the three dissected the difference between compensation, inducement, and reimbursement. The mock IRB session was also impactful. At the end of the first weekend retreat, my aim and objectives were achieved.

However, I had curiosity in me to research (know) more about the sponsor of the program - Fogarty International Center, National Institute of Health (FIC, NIH) during the weekend retreat. This led me to register for the 2021 NIH Virtual Seminar on Program Funding and Grant Administration (held November 1-4). Through this program, I connected and exchanged messages with Dr. Barbara Sina (FIC lead for Bioethics Programs) and Dr. Brad Newsome (Program Officer, Division of International Training and Research, FIC, NIH). I had a one-on-one zoom meeting with Katie Stinson (MyNMRN Liaison) of the National Research Mentoring Network (NMRN) as well and relayed my grateful message to FIC to her at the end of the meeting for funding Diploma in Research Ethics in Nigeria where I have immensely benefited from.

Meanwhile, the second-weekend retreat was approaching after another four weekly cycles of elearning and the weekend chat room session was coming to an end. From the conversation with other students, we were all eager to arrive for the second-weekend retreat as we know we will again be baptized with more knowledge of research ethics and so it was. The presentation of a certificate of completion at the end of the second and final weekend retreat brought a smile to my face like a researcher successfully concluding his research study with remarkable results, discussion, and conclusion.

The program, being multi-disciplinary, availed me the opportunity to connect with other students who are respected figures in other disciplines like Prof. Obatunde Adetola (Professor of Development Sociology), Barrister Nna Ogbonna (Legal Practitioner), Dr. Ajibola Alabi (Pediatrician), Mrs. Agbaje Becky (Ethics Committee Administrator), Dr. Erohubie Paul (Psychiatrist) to mention a few. I will forever be grateful for this program as it is a turning point in my professional and research life.

These trainings are part of the requirements by the National Health Research Ethics Committee (NHREC) for members of an Ethics Committee and the registration of newly inaugurated Ethics Committees.

4.0 Onsite International Health Research Ethics Committees and Health Researchers training

CBR, Nigeria collaborated with the College of Medicine and Allied Health Sciences (COMAHS), University of Sierra Leone; Sierra Leone Ethics and Scientific Review Committee (SLESRC); Pharmacy Board of Sierra Leone; and King's College London, with support from the European and Developing Countries Clinical Trials Partnership (EDCTP), to hold a three day Research Ethics Training Workshop for members of the Sierra Leone Research Ethics Committee and representatives from some research hubs in Sierra Leone. The training which was from 23rd – 25th November 2021 had 37 participants drawn from different health and research institutions in Sierra Leone.

5.0 New CBR Programs

5.1 CBR e-Mentoring Program

CBR recently launched an e-mentoring program for trainees and researchers in the field of health research ethics and health research in general. The program provides structured mentoring for in Research Ethics, Responsible Conduct of Research, and general research career development. The program was established to support the career development of local researchers, members of ethics committees and bioethicists. The e-mentoring program addresses the problem of lack of local mentoring resources by recruiting accomplished local and international researchers to mentor, provide career guidance and support for mentees. The mentoring process is proactive and managed by a program manager at CBR.

To support mentors and mentees, the program includes compulsory training courses in mentoring, behavioral nudges, and inducements to support establishment of successful mentoring relationships. The e-mentoring program is integrated into the postgraduate degree programs supported by the Center for Bioethics and Research (CBR) in different Nigerian universities but is also available to interested individuals/groups outside of these programs. 5.2 CBR Sexual Harassment and Safe Working Environment Training Programs

5.3 CBR constitutes a Health Research Ethics Committee

It safeguards the rights, dignity and welfare of the individuals volunteering to participate in research studies. The members of the committee are well respected persons from diverse backgrounds with prior experience of serving on an ethics committee. The Committee is an independent body comprising of experts and lay member and is supported by appropriate research and medical advisers.


